#### 3. HAZARDS IDENTIFICATION

**Main hazards:** Highly flammable.

Other hazards: In use, may form flammable/explosive vapour-air mixture

## 4. FIRST AID MEASURES

**Skin contact:** There may be irritation and redness at the site of contact. Wash with soap

**Eye contact:** There may be irritation and redness. Promptly wash eyes with plenty of
